For your information and in accordance with our Constitution an extract from the current CORC Constitution appears below:

Section 3.10 – Election of the Board

The election of Directors to replace those whose term has expired shall take place at the annual meeting of the members, or at a special meeting called and held for that purpose. At least twenty (20) days prior to the date of which such election is held, the President shall appoint a Nominating Committee consisting of three (3) persons who may but need not be Directors. Such committee shall prepare a list of candidates to fill the Board of Directors and nominate such candidates at the meeting. Other nominations may be made from the general membership; however, any candidate's name so placed in nomination must be submitted in writing and accompanied by written consent of the nominee to the Nominating Committee at least ten (10) days prior to the annual meeting.

If you are nominating someone to the Board, be sure to also check the CORC Constitution, Section 3.01 at www.corc.us for the Minimum Qualifications of Directors. The Constitution is available on WWW.CORC.US.

As allowed by our Constitution, all CORC members who regularly request email newsletters are being notified of this Annual Meeting by email. The balance are receiving their notice by US mail.

Our next meeting (after this one) will be the "**50+2 BIG EVENT**". It will be held on June 5th. There will be lots of prizes and surprises at that event. Hopefully the Covid virus will allow for an actual potluck by then. There will be additional details in the next full newsletter.
