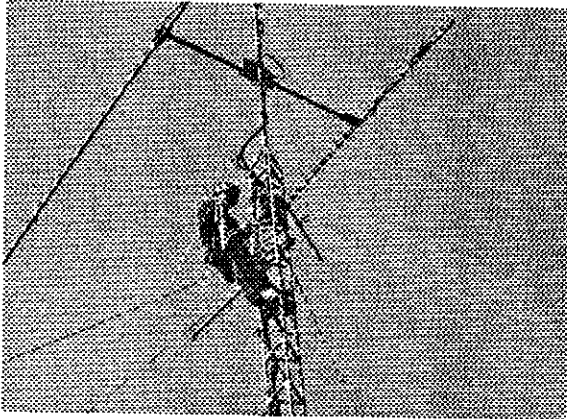


Up a Tree, err... Tower with a Rope!

It was a nice, breezy fall day and John Perone, W8RXX, made the trek up W8NBA's tower. What happened was the link on the 147.33 repeater was acting up and after repairing the link transmitter at the Jersey site, another problem was found in the connector of the link receive antenna. That link is now repaired and working well. There still is a problem with the downtown receive site. We are having problems gaining access to that site, but will be repairing it as soon as we can. Until then the local receiver site antenna was changed to a 11-element beam pointed towards the west to improve coverage until the downtown site can be repaired. The patch is operational and all other functions work as normal.



Again, we need to thank John for all the volunteer time and effort he puts in, keeping the club's repeaters in working condition. Without him and the rest of the technical committee, keeping the repeaters on the air would be impossible. Even with the advent of cell phones and pagers, it's comforting to know that the repeaters will be there if and when you need them.

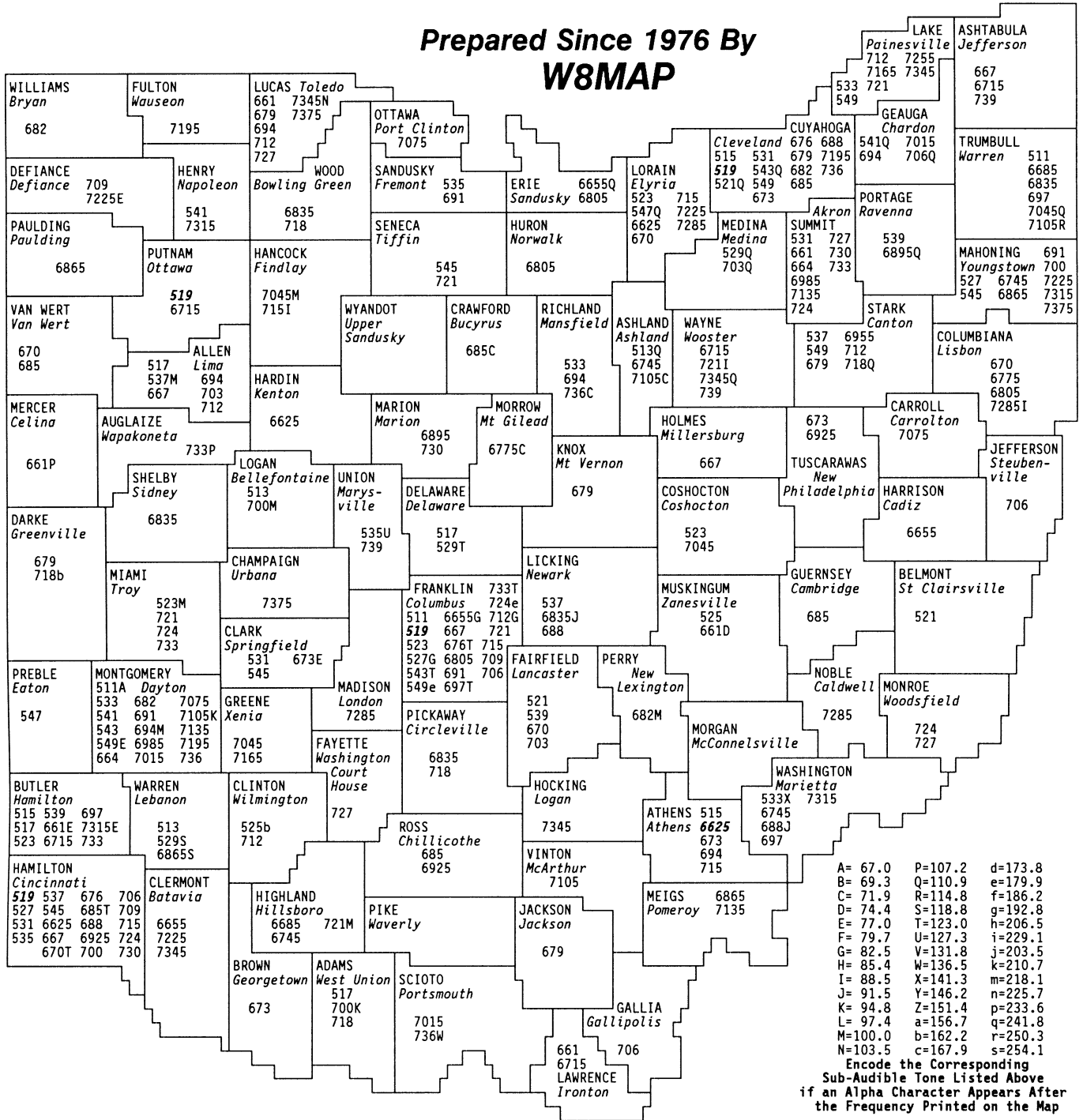
